



NATIONAL CAR RENTAL PROTECTION

A. LOSS DAMAGE WAIVER (CDW)

This insurance (**Loss Damage Waiver**), its lost responsibility by damages of our vehicles will be limited. In case of accident, the maximum deductible by direct damage to the rented vehicle will be of \$ 800.00 for 4x4 and SUV, OF \$500.00 for Sedan. In case of partial or total theft, the deductible is 20% of the vehicle value. Nevertheless, L.D.W. it will be V if the vehicle is surrounded in anyone of the “violations and described prohibitions of use” in the rent contract.

Are exclude from coverage glass, tires and radio.

Deductibles

In Nicaragua in the case of trucks 4x4 and SUV, deductible is \$ 800 and for Sedan cars is \$500. In case of partial or total theft deductible is 20% of value of the vehicle.

C. SUPPLEMENTARY LIABILITY COBERAGE (SLC)

This insurance is a mandatory and can not be declined with any credit card.

The minimum deductible is \$250 to damage to the property of third parties. In Nicaragua, for damage to third party property insurance will cover up to \$ 100,000.00 in property damage caused to third parties or third party vehicle and third parties death \$ 5,000.00 for 1 person for 2 or more people \$ 10,000.00. The customer will pay for 100% of the damage to the rented vehicle. Regardless of whether he is guilty or not of damage to our vehicle.

Is excluded from coverage any client who commits negligence against Traffic Laws of the country concerned or any other stipulated in the rental agreement, does not cover properties

Up to third degree relatives of consanguinity or people living under the same household of the insured.

D. WINDOWS & TIRES PROTECTION

The purpose of this protection is to exempt of the payment of damages by tires or windows problems. There is no deductible for this coverage.



F. Maximum Coverage

Damage is 100% covered with 0% deductible. Is protected against theft, Collision and rollover, third party protection, Rhines, wheel, windshield and Vandalism. They just need to present police report. Is excluded from coverage any client who commits negligence against Traffic Laws of the country concerned or any other stipulated in the rent contract, does not cover properties up to third degree relatives of consanguinity or persons living under the same household of the insured. It is essential to apply this coverage, submit the legal documents required by the contract of Lease. The deductible amount is only \$0.

Accidental death: Pilot will receive an amount of \$ 18,500.00 and \$ 2,500.00 passengers also equivalent to medical expenses.

Service Funeral expenses for the pilot in case of death or the equivalent of \$ 2,500.00.

H. Coverage Polices

- 1-Under no circumstance, it is not allow driving while drinking any alcoholic drink
 - 2- Driving in places not suitable for the car.
 - 3- Three-Any negligence cused by the driver
 - 4-While an accident, the driver is not register under the rental agreement
